



Annual List of Obligated Projects Federal Fiscal Year (FFY) 2024

Annually, the State, public transportation operator(s), and the Metropolitan Planning Organization (MPO) must develop a listing of all federally funded transportation projects authorized in the preceding program year. As the region's MPO, the Bangor Area Comprehensive Transportation System (BACTS), is responsible for compiling and publishing the complete list of obligated projects. Listings are classified under the Federal Highway Administration (FHWA) which includes State and local highway projects and the Federal Transit Administration (FTA) which includes transit projects.
